Fortis Net Lease is pleased to present a Wendy's Restaurant located at 1010 East Hollywood Avenue in Blytheville, AR. There is a six year absolute net lease in place with no landlord responsibilities. The lease has five, one year options with 1.5 percent annual rent increases. Meritage Hospitality Group, Inc. is the lease guarantor.

The subject property has over 23,500 residents within ten miles and is located in a local retail corridor east of downtown Blytheville. The restaurant is situated on East Hollywood Avenue which is less than one mile from Interstate 55. It is approximately one mile from Walmart, Tractor Supply Company and Lowe's and five miles from Arkansas Northeastern College (1,425 Students). There are five hotels within a mile of the restaurant and it is approximately six miles from the Arkansas International Airport. The median home value within ten miles exceeds \$79,000 and the average household income exceeds \$52,000. The subject property is located near other national retail tenants including Walmart, Dollar Tree, CATO, O'Reilly Auto Parts, Hibbett Sports, JCP, Family Dollar and Dollar General.

Blytheville, AR

Blytheville is the largest city in Mississippi County, Arkansas. Blytheville is approximately 60 miles north of West Memphis. The population was 18,272 at the 2000 census.

Blytheville was founded by Methodist clergyman Henry T. Blythe in 1879. It received a post office in 1879, was incorporated in 1889, and became the county seat for the northern half of Mississippi County (Chickasawba District) in 1901.

Forestry was an early industry, spurred by the massive harvesting of lumber needed to rebuild Chicago following the Great Fire of 1871. The lumber industry brought sawmills and a rowdy crowd, and the area was known for its disreputable saloon culture during the 1880s and 1890s.

The cleared forests enabled cotton farming to take hold, encouraged by ongoing levee building and waterway management; the population grew significantly after 1900. On Blytheville's western edge lies one of the largest cotton gins in North America, and soybeans and rice have also become important crops. The area around Blytheville continues to be farmed, though family farms have given way to large factory operations.

In the 1980s, Blytheville began to develop an industrial base, much of which centered on the steel industry.

Until 1991, Blytheville was home to Blytheville Air Force Base (later renamed Eaker Air Force Base), a major airfield that was part of the Strategic Air Command.
