

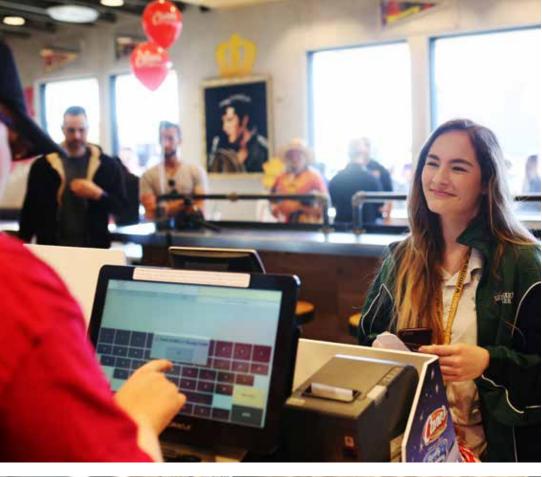

Raising Cane's Chicken Fingers is a fast-food restaurant chain founded in 1996 in Baton Rouge, Lousiana. The company, privately held by its founders, is still headquartered in Baton Rouge and has more than 300 locations in 21 states with multiple new restaurants under construction. Raising Cane's recently announced that by the end of 2020, it plans to grow by 350 restaurants to a system-wide total of 600 and reach \$1.5 billion in sales --nearly three times the \$565 million it generated in 2015. Further, the year-over-year increase in top line revenue was approaching 30 percent.

Raising Cane's outscored Chick-fil-A in the chicken category when it came to customer loyalty, as measured by Boulder, Colorado-based research agency Market Force Information.

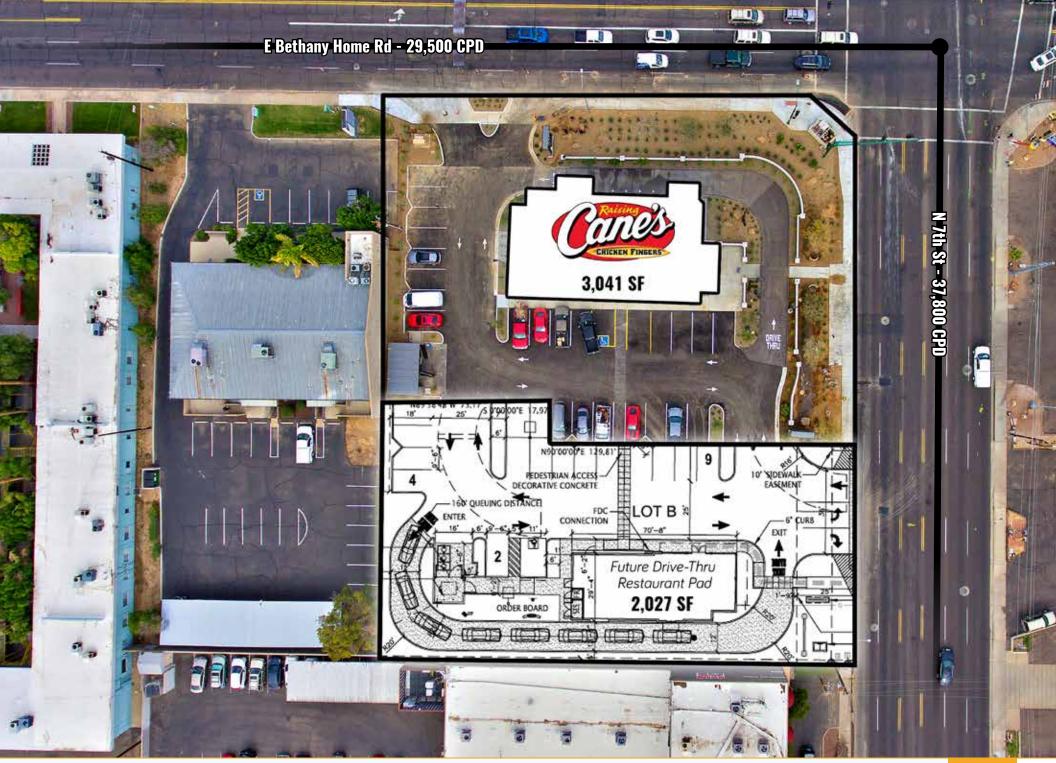
