#### **LOCATION OVERVIEW:**

This Rite Aid property is located in Henderson, Kentucky at the north west corner of 5th and Green Streets at a traffic signal. Neighbors include Methodist Hospital, Family Video, Dollar General, Captain D's, O'Reilly Auto Parts and many other retail/office users. Green Street has been a long-term North/South travel corridor.

Henderson, KY is located along the Ohio River in Henderson County in Western Kentucky. It is part of the Evansville Metropolitan Area, locally known as the "Tri-State Area." Each year Henderson hosts a variety of events and festivals. The Henderson Breakfast Lions Club holds the Tri-Fest, a street festival that raises funds for non-profit organizations, in mid-April each year.
