One of Minnesota's fastest growing cities, Woodbury is now the state's 9th largest city. The population of close to 70,000 (26,000 households) is projected to reach 88,000 by 2040 and is expected to continue attracting new residents for years to come. According to the 2010 U.S. Census 60.5 % of the residents age 25 or older are college graduates. It is in close proximity to major employment centers, as well as the St. Croix River Valley.

Woodbury is known for its attractive residential neighborhoods, which are connected by more than 140 miles of multi-use trails. The city contains approximately 3,100 acres of parkland and eight small lakes, most with public parks and pathways. The city has consistently been recognized nationally as a great place to live, work and thrive.

What brings outsiders to Woodbury? Sports and health care. The city's HealthEast Sports Complex, which houses 18 softball fields, two ice rinks, and a volleyball court, often hosts pro games. U.S. and international tourists seeking top medical care are drawn to Woodbury's more than 120 health-care firms, including several of the country's best hospitals. The area is commonly known as the Twin Cities for its two largest cities, Minneapolis and Saint Paul. Minneapolis lies on both banks of the Mississippi River, just north of the river's confluence with the Minnesota River, and adjoins Saint Paul, the state's capital. The city is abundantly rich in water, with twenty lakes and wetlands, the Mississippi River, creeks and waterfalls, many connected by parkways in the Chain of Lakes and the Grand Rounds National Scenic Byway.








