KinderCare Learning Centers provides educational programs for children from six weeks to 12 years old throughout the United States. KinderCare Education is the largest provider of early childhood education and care in the nation. Some 200,000 children are enrolled in more than 1,600 early childhood education community centers, over 600 before-and-after school programs, and over 100 employer-sponsored centers in 39 states and the District of Columbia. The company was founded in 1986 and is based in Portland, Oregon. Perry Mendel, a real estate developer, founded KinderCare after speculating that increasing numbers of women entering the work force would increase demand for preschool child care. The idea behind the firm was to provide child care in bulk using economies of scale. Perry Mendel, a real estate developer, founded KinderCare after speculating that increasing numbers of women entering the work force would increase demand for preschool child care. The company began as KinderCare Nursery Schools, and the first facility was opened on July 14, 1969 accommodating 70 children. In 2018 KinderCare Education acquires Rainbow Child Care Center, expanding to more than 1,500 learning centers, serving 185,000 children across the United States.
