The property consists of 2,472 square feet of building space and is situated on approximately 2.01 acres of land. The property is subject to a 20-year triple-net (NNN) lease with 14.45 years remaining. The annual rent is currently \$85,463 and will be subject to 8.00% rental increases every five years. The rental increases will continue through the four, five-year tenant renewal options. The tenant on the lease is FQSR, LLC which does business as KBP Foods, a 600+ unit operator with operations in 23 states.



## **Concept Overview**



### **About KFC**

Kentucky Fried Chicken (KFC) is a fast food restaurant chain that specializes in fried chicken and is headquartered in Louisville, Kentucky, United States. It is one of the world's largest restaurant chains with over 22,000 locations globally of September 2018. The company is a subsidiary of Yum! Brands, a restaurant company that also owns the Pizza Hut and Taco Bell chains.

KFC was founded by Harland Sanders, an entrepreneur who began selling fried chicken from his roadside restaurant in Corbin, Kentucky, during the Great Depression. Sanders identified the potential of the restaurant franchising concept, and the first "Kentucky Fried Chicken" franchise opened in Utah in 1952. KFC popularized chicken in the fast food industry, diversifying the market by challenging the established dominance of the hamburger. By branding himself as "Colonel Sanders", Harland became a prominent figure of American cultural history, and his image remains widely used in KFC advertising.

KFC was one of the first fast food chains to expand internationally, opening outlets in Canada, the United Kingdom, Mexico, and Jamaica by the mid-1960s. The chain continued to expand overseas and in 1987 KFC became the first Western restaurant chain to open in China. The chain has since expanded rapidly in China, which is now the company's single largest market.

KFC's original product is pressure fried chicken pieces, seasoned with Sanders' recipe of 11 herbs and spices. The constituents of the recipe represent a notable trade secret. Larger portions of fried chicken are served in a cardboard "bucket", which has become a well known feature of the chain since it was first introduced by franchisee Pete Harman in 1957. Since the early 1990s, KFC has expanded its menu to offer other chicken products such as chicken fillet burgers and wraps, as well as salads and side dishes, such as French fries and coleslaw, desserts, and soft drinks.

- KFC is one of the world's largest restaurant chains, and the world's most popular chicken brand.



### **Location Overview**

This KFC is located at 1445 West Bristol Road in Flint, Michigan. Flint is the largest city and county seat of Genesee County, Michigan, United States. Located along the Flint River, 66 miles northwest of Detroit, it is a principal city within the region known as Mid Michigan.

### **SURROUNDING RETAIL & POINTS OF INTEREST**


This KFC property is strategically located within close proximity to major highways, large-scale commercial enterprises, and many other national retailers. National retailers include: McDonald's, Walgreen's, Rite-Aid, Dollar General, Chase Bank, AutoZone, and more. General Motors, the city's largest employer, conducts the majority of its manufacturing processes within a mile of the subject property. Additionally, Baker College-Flint enrolls over 1,300 students each year and is located less than a mile from this KFC. The Baker College System Headquarters are located adjacent to the academic buildings, bringing additional faculty to the area daily. The system has 11 campuses and is the largest independent, not-for-profit college in Michigan. Bishop International Airport, which serves over 700,000 passengers annually, is located approximately one mile from this KFC. The subject property is also located less than five miles from the 416-bed McLaren Flint Hospital and the 443-bed Hurley Medical Center.


#### TRAFFIC COUNTS & DEMOGRAPHICS

Flint has approximately 53,000 individuals residing within a three-mile radius of this KFC and about 130,000 individuals within a five-mile radius. The KFC property is located on West Bristol Road, which experiences an average daily traffic count of 34,000 vehicles. Intersecting with West Bristol Road is Van Slyke Road, which experiences an average daily traffic count of 19,000 vehicles. Nearby, Interstate 75 brings an brings an additional 78,000 vehicles per day to the area and serves as an artery to Detroit.


### FLINT, MI

Flint is well positioned for trade at the crossroads of Interstate 69 and Interstate 75. Since 2011 General Motors has invested over \$5 billion between its Flint engine operation and vehicle assembly plants. The metro area also hosts the headquarters to four national insurance companies, including Auto-Owners Insurance Co. Higher education is another key economic driver for Flint, which is home to the University of Michigan–Flint, Kettering University, Mott Community College, The Michigan State University College of Human Medicine, Baker College, and satellite campuses of Davenport University and Spring Arbor University. In September of 2017, Bishop International Airport received a \$4,300,000 grant from the Federal Aviation Administration for maintenance and runway upgrades. Over 700,000 passengers a year travel through Flint by way of Bishop International Airport.
