The PetSmart's lease expires August 31, 2022 and features four 5-year renewal options with 10% rental escalations in each option. In addition, South Dakota is an income tax free state. There are over 72,000 people living with five miles of the property. The Rapid City market boasts a 2.4% vacancy rate and is the second largest market in the state. The trade area is expansive, reaching 200 miles into Nebraska and 150 miles into Wyoming.

The 20,374 square foot building is located immediately off Interstate 90 (33,090 VPD) in Rapid City's primary retail corridor. The property is just west of Rushmore Mall, which anchored by JCPenney and At Home. Additional retailers in the area include Kohl's, Lowe's, Best Buy, AMC, Sam's Club and Walmart Supercenter. Rapid City is a national tourist destination due to its close proximity to Mount Rushmore National Memorial and the 10-day Sturgis Motorcycle Rally. The largest sector of the Rapid City economy is government services, including local, state, and federal. Major employers include Ellsworth Air Force Base, home of the 28th Bomb Wing flying the B-1B long-range bomber; the Army National Guard based at Camp Rapid and hosting annual exercises in the Black Hills drawing troops from five to ten states; and various federal agencies including the National Park Service, US Forest Service, and Indian Health Service. Ellsworth Air Force Base employs over 5,000 military and civilian personal and contributes 10% of the total sales to the Rushmore Mall.


### Rapid City, South Dakota, Illinois
