Fort Walton Beach is a small city in the Florida Panhandle and is located between Pensacola and Panama City along North Florida's glittering Gulf Coast, Fort Walton Beach offers visitors its powdery white beaches, emerald waters, enjoyable golf courses, and much more. Fort Walton Beach boasts all the fun of the major vacation spots, minus the fuss. Home to family-friendly resorts and attractions such as parks, museums and aquariums. It's known for fine white-sand beaches on adjacent Okaloosa Island. The island's Gulfarium Marine Adventure Park is home to dolphins, penguins and alligators.

The city of Fort Walton Beach Heritage Park & Cultural Center consists of the Indian Temple Mound Museum, Fort Walton Temple Mound, Camp Walton Schoolhouse Museum, Garnier Post Office Museum and the newly opened Civil War Exhibit Hall. 







DEPOSIT COMPETITION MAP




