The Dunkin' Donuts property was recently constructed in 2017 and features a fifteen year absolute triple net lease. There are 10% rental escalations every five years and two 5-year renewal options. This site is a second generation store where due to the success of the first location, the tenant wanted a newer and larger store. The lease is guaranteed by a 30+ unit operator with locations throughout the northeastern and mid-Atlantic United States.

The 1,868 square foot property is well located along the Allentown Pike (25,096 VPD) which is the primary east-west thoroughfare in the region and connects Allentown to Reading. The Dunkin' Donuts is adjacent to a Cadillac dealership and near Sheetz and Speedway. The average household income within five miles of the property is \$82,888.




MARKET OVERVIEW:


