ABOUT THE BRAND

Kentucky Fried Chicken (KFC) is a fast food restaurant chain that specializes in fried chicken and is headquartered in Louisville, Kentucky. It is the world's second largest restaurant chain (as measured by sales) after McDonald's, with almost 20,000 locations globally in 123 countries and territories as of December 2015. The company is a subsidiary of Yum! Brands, a restaurant company that also owns the Pizza Hut and Taco Bell chains. KFC was founded by Harland Sanders, an entrepreneur who began selling fried chicken from his roadside restaurant in Corbin, Kentucky during the Great Depression. Sanders identified the potential of the restaurant franchising concept, and the first "Kentucky Fried Chicken" franchise opened in Utah in 1952.

In 2018 KFC sales were \$4.4 billion, which was 2% higher than the previous year, and they only continue to grow. KFC is Yum Brands largest brand, and their sales posted 5% same-store growth globally in 2018, exceeding analysts expectations for 3.1% growth. CFO Brian Cahoe plans to grow KFC by 100 stores a year starting in 2019, and is looking to expand in Universities, Airports, and even Ball Parks.







LYNN HAVEN, FLORIDA

Lynn Haven is a city in Bay County, Florida, north of Panama City. As of the 2017 census, the population of Lynn Haven was 20,922. The median household income for Lynn Haven is \$60,664, and the Estimated Per Capita Income is \$27,146. The median house value is \$201,648, and the annual growth rate of the city annually is currently at 1.33%. Lynn Haven is considered a military town as it is less than 20 miles from Tyndall Air Force Base, Eglin Air Force Base, and Duke Field. Lynn Haven is only 16 miles from the Northwest Florida Beaches International Airport, and is only 6 miles from downtown Panama City, Florida.

Lynn Haven is widely known as a tourist town, as it is located centrally to many of Florida's beaches in the Saint Andrew Bay, as well as the Gulf of Mexico. There are also six public schools as well as two charter schools, and the cities total area is 11.8 square miles. Aside from the beaches and the military bases, Lynn Haven community is especially focused on recreational activities and community events. The Lynn Haven Sports Complex is over 20 AC of open space and there are 8 additional parks in Lynn Haven, one being a splash pad and boat slide. The community is very involved in Lynn Haven and the population remains steadily growing.


