





Saginaw is the county seat of Saginaw County in the state of Michigan. The city of Saginaw and Saginaw County are both in the area known as Mid-Michigan or Central Michigan. The city is adjacent to Saginaw Charter Township and considered part of the Tri-City area, along with neighboring Bay City and Midland. The Saginaw County MSA had a population of 200,169 in 2018. The city is also the largest municipality in the Saginaw, Midland, and Bay City Metropolitan Area. Saginaw was known as a thriving lumber town in the 19th century and an important industrial city and manufacturing center throughout much of the 20th century.


The economy of Saginaw, MI employs 17,800 people. The largest industries in Saginaw, MI are Health Care & Social Assistance, Retail Trade, and Manufacturing, and the highest paying industries are Utilities, Transportation & Warehousing, & Utilities, and Professional, Scientific, & Technical Services. Economic development is focused on comparative advantages in innovation, clean energy, and continued manufacturing exports. Compared to other mid-sized communities, Saginaw has a disproportionately high number of patents per employee, and more than 81 times the average US share of jobs in photovoltaic technology research and production. The city continues to have a higher proportion of manufacturing jobs than the US average.

The city is home to the Saginaw Children's Zoo with interactive exhibits featuring 150 animals, 80 gardens & a hand-painted carousel. The city includes the Castle museum of Saginaw County History which focuses on local history in a French Renaissance Revival-style building from 1898. The city is also home to the Mid-Michigan Children's Museum which is a colorful attraction with hands-on, interactive exhibits designed for children under age 10. The area is also home to the Japanese Cultural Center and the Saginaw Art Museum.
