

Kiddie Academy provides its franchisees with curriculum and helps them obtain all the licenses and permits necessary to build and operate the business. Kiddie Academy locations are independently owned and operated by qualified professionals. The company sold its first franchise agreement in 1993, and expanded outside Maryland in 1996. The company's 200th franchise opened in Vancouver, Washington in December 2017. By the end of 2018, the company had opened more than 210 locations in 29 states and the District of Columbia. The company projects 40 new Academies to open in 2019, which would grow the network to more than 250 open and operating locations.












