

ANDOVER, MN | CITY SUMMARY

Andover is a city situated less than 23 miles north of Minneapolis in Anoka County. Established in 1972, Andover provides a high quality of life for residents with quiet neighborhoods, recreational opportunities, quality schools and proximity to the economic and cultural opportunities available in the Minneapolis-Saint Paul metropolitan area, of which Andover is a part. Andover's estimated population of 33,000 is considered affluent and highly educated for the state and the nation. In 2019, the average household income was \$139,235 and more than 36% had earned a college degree.

The economy of Andover primarily features local retailers, service providers, and municipal agencies. In 2018, the largest employers included the local school district, Walmart, a healthcare clinic and the Anoka County Sheriff's Office. The city is encouraging economic development in its commercial corridor centered around Bunker Lake Boulevard.

While much of the economy revolves around the local community, the city is also part of the larger economy of the Twin Cities of Minneapolis and Saint Paul. The Twin Cities' economy is an anchor point in the Midwest– second only to Chicago– and is based on finance, tech, industry, commerce, health care, and logistics. It is the 15th largest economy by gross domestic product in the nation according to data from the Bureau of Economic Analysis, with a GDP of \$260,106 million. Several Fortune 500 companies are headquartered in the Twin Cities MSA including UnitedHealth Group, Target, Best Buy, 3M, CHS, U.S. Bancorp, C.H. Robinson, General Mills, Supervalu, Land O'Lakes, and more.

Andover's 35 square miles encompasses ample outdoor recreation space including a recreational lake, woodlands, meadows and nature preserves. There are more than 400 acres of community and neighborhood parks that offer hiking, biking, skiing, golfing, camping and other outdoor activities. Additionally, Andover has easy access to the endless amenities of Minneapolis, Saint Paul and Bloomington, including Mall of America, the largest mall in the country and the twelfth largest in the world.
