This new building features upgraded brick and EFIS construction and is situated on .98 acres of land. The property is located on Norwich Rd. (Rt. 12). Dollar General is strategically located on the main retail thoroughfare surrounded by many local business as well as national tenants along Norwich Rd. Norwich Rd. runs parallel to the Connecticut Turnpike (I-395). The property is less than 1-mile from exit 29 off the turnpike which has a Park & Ride lot providing convenient access to commuters. Also located in Plainfield, a short distance from the property are distribution facilities for Lowe's (1.36 million s/f) and Staples (350,000 s/f).

Plainfield is approximately 35 miles east of Hartford. It is located near the CT / RI border and is ~25 miles west of Providence, RI. Plainfield is one of the towns which borders Pachaug State Forest. It is the largest forest in the Connecticut state forest system, encompassing over 27,000 acres of land. It is located on the Rhode Island border in New London County, and parcels of the forest lie in the towns of Voluntown, Griswold, Plainfield, Sterling, North Stonington, and Preston. The forest was founded in 1928, but most of the land came from purchases made later during the Great Depression. It is named after the Pachaug River, which runs through the center of the forest. The forest is part of the Northeastern coastal forests ecoregion.

(KKR) (NASDAQ: KKR) acquired Dollar General, privatized the company for restructuring, and took the company public again in 2009. As of March 1, 2019, Dollar General Corporation operated 15,472 stores in 44 states.

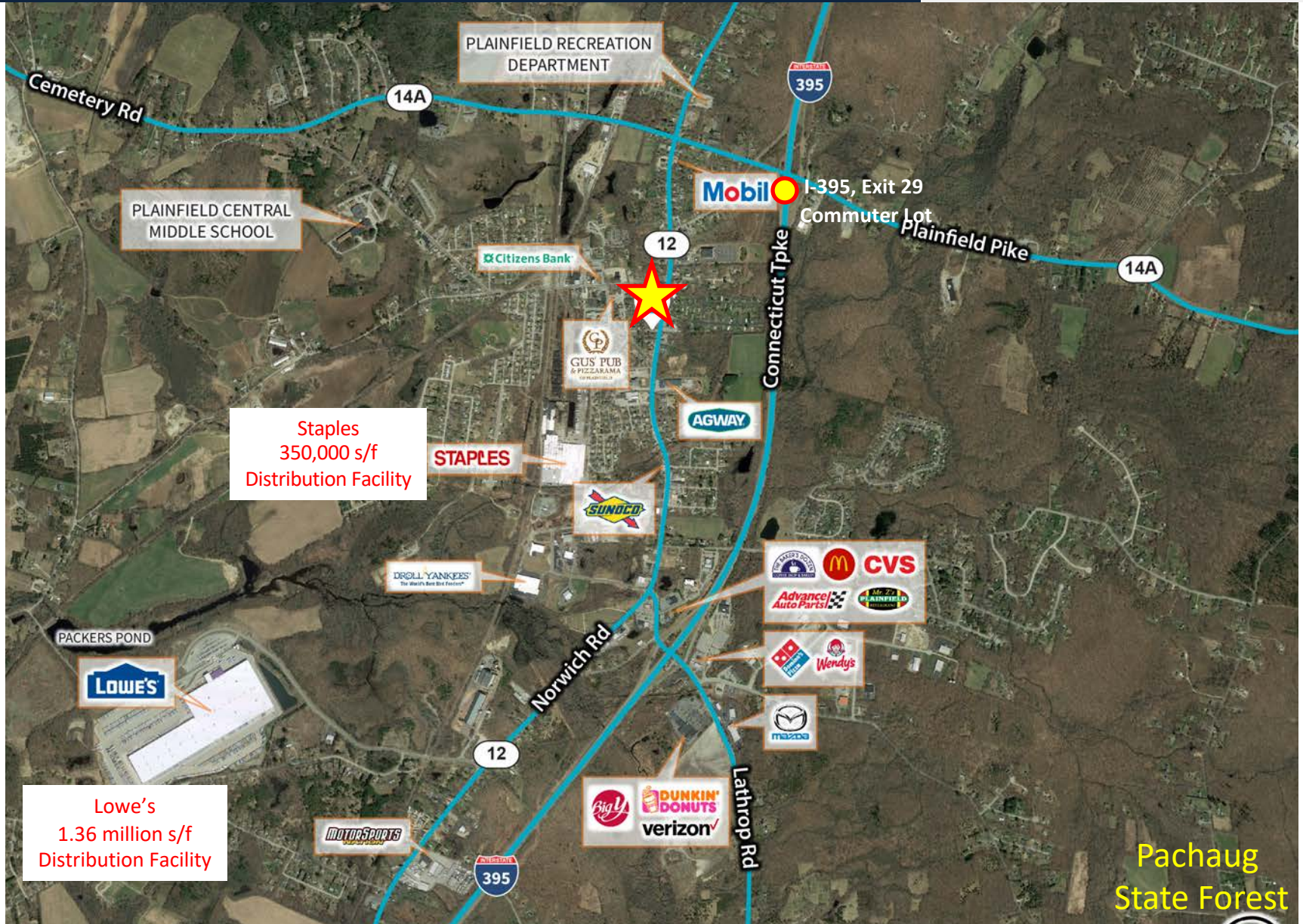

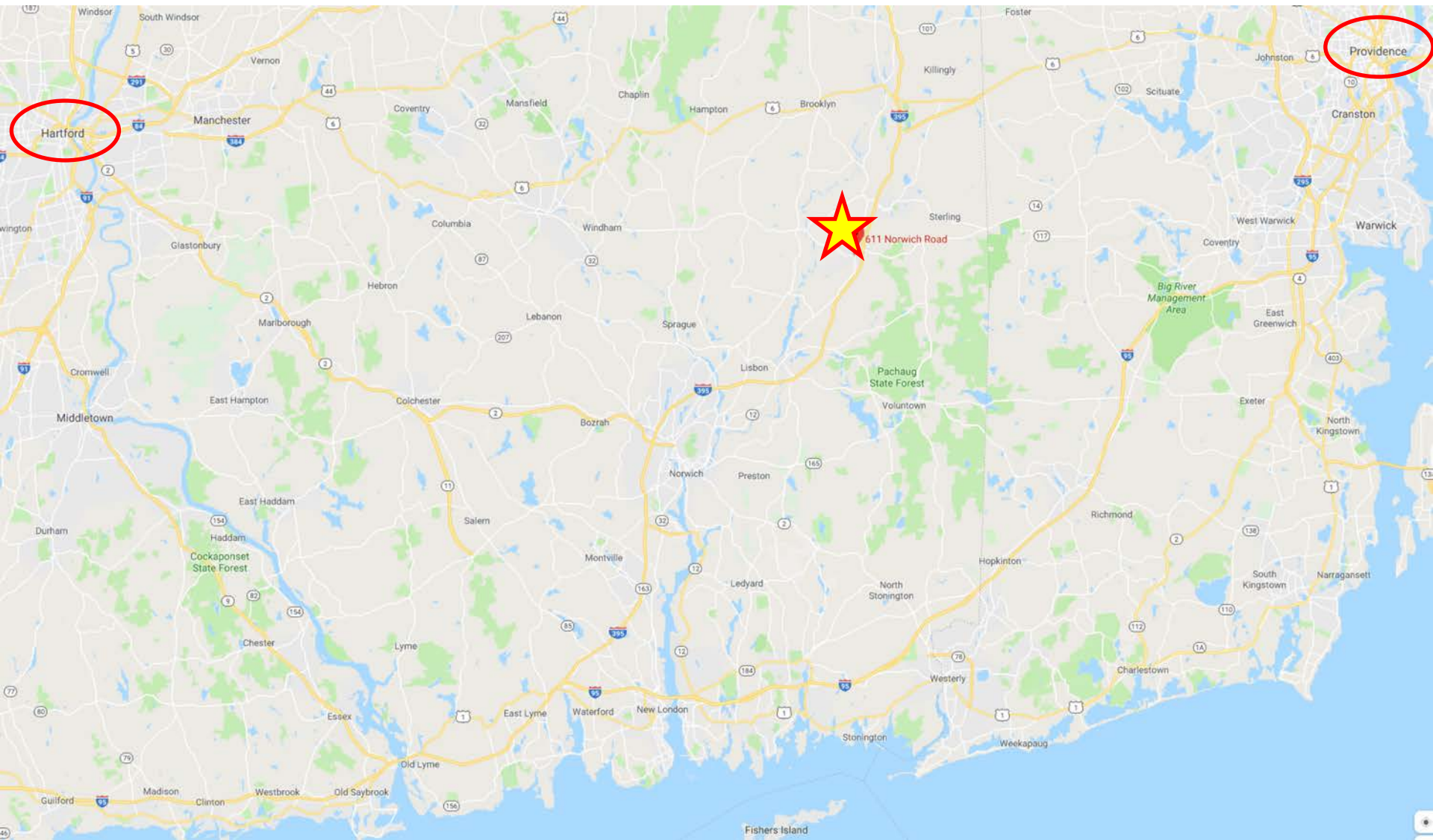
