

#### **Richland County Overview**

Richland County currently has population of approximately 119,490 with a median household income of \$49,000. Residents spend an average of 21 minutes commuting to work, 60-percent to white collar jobs and 39-percent to blue collar jobs. The area is a hub for industrial production, home to one of America's most productive electric furnace steel mills, while local metal fabrication and plastic component production companies supply U.S. and foreign automakers. The county holds a significant position in the sensor and plastics industry and is one of the leading developers of hydrogen fuel cells for power production. Richland County is served by 57 airports within 50 miles.

#### Mansfield Overview

Mansfield is a city in and the county seat of Richland County, Ohio. Located on a major east-west highway corridor midway between Columbus and Cleveland, it is part of the Northeast and North-Central Ohio regions in the western foothills of the Allegheny Plateau. It is the largest city in the Mid-Ohio region of the state, with a population of over 46,500 as of 2018 estimates. The city lies approximately 65 miles northeast of Columbus, 65 miles southwest of Cleveland via Interstate 71 and 90 miles southeast of Toledo.


Anchored by the Richland Carousel District, downtown Mansfield is home to a number of attractions and arts venues. Concert events in the downtown Brickyard venue have drawn crowds numbering over 5,000 people. Home of the Mansfield Symphony Orchestra, the Renaissance Performing Arts Association annually presents and produces Broadway-style productions, arts education programs, concerts, lectures, and family events to more than 50,000 people in the historic Renaissance Theatre. Mansfield Public Schools enroll 4,591 students in public primary and secondary grades. Mansfield is also home to three institutions of higher learning: an Ohio State University regional campus, North Central State College, and Ashland University's Dwight Schar College of Nursing & Health Sciences. Mansfield's economy has diversified yet continues to rely on manufacturing.

## **Employment Overview**

Despite decades of manufacturing employment decline, the Mansfield region still has an above average proportion of manufacturing jobs (LQ of 2.42). The Mansfield region also has an above average number of employees in Retail Trade, Administrative and Support Services, Health Care, Accommodations and Food Services, and Government. The region has relatively fewer "white collar" jobs in the Management, Professional, Scientific, and Technical Services, and Finance and Insurance sectors.

Though the manufacturing sector remains the primary employer in the region (just under 16 percent of total employment), the healthcare industry has the second highest concentration in employment with just over 13 percent, up from around 10 percent in 2001.
