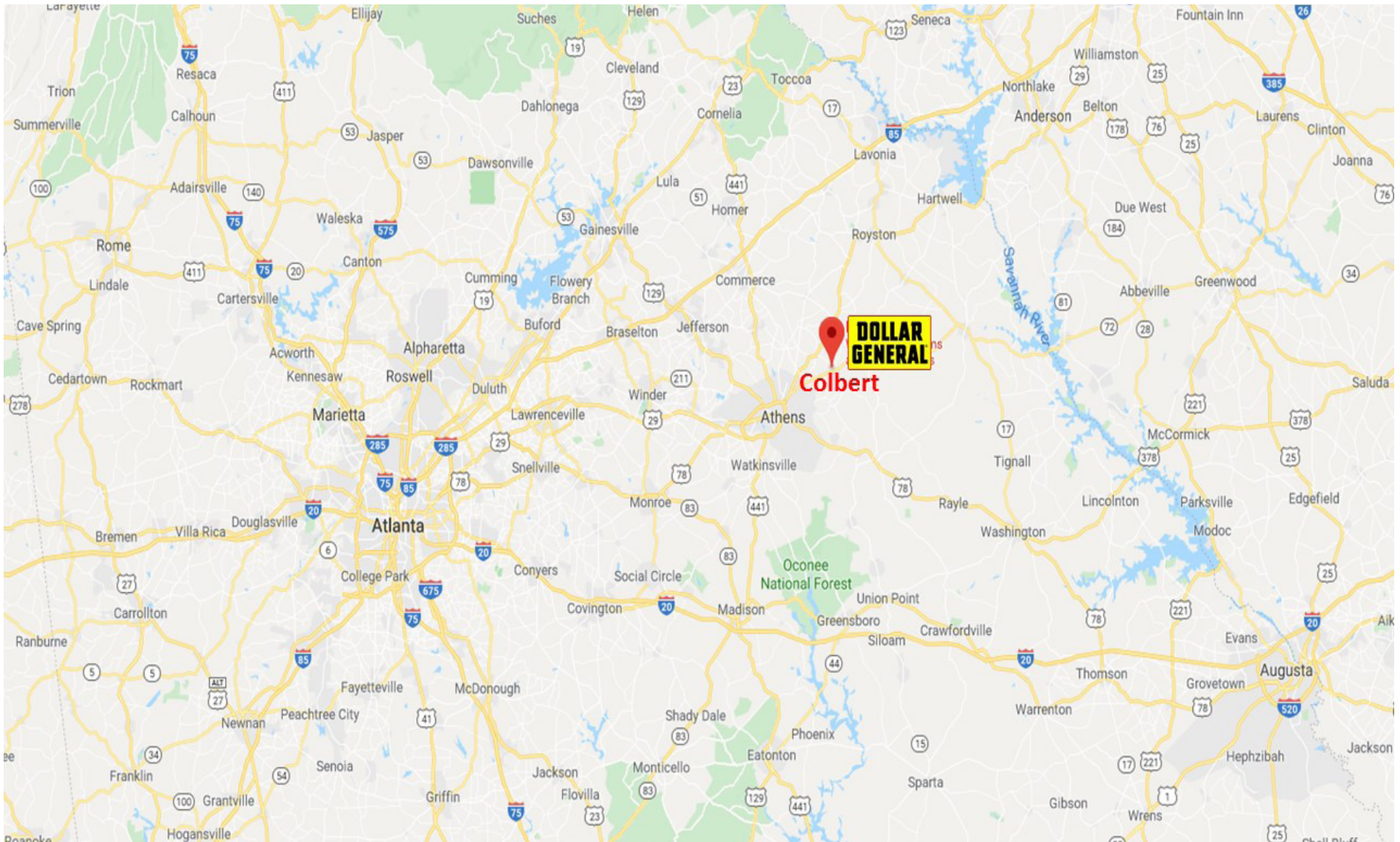

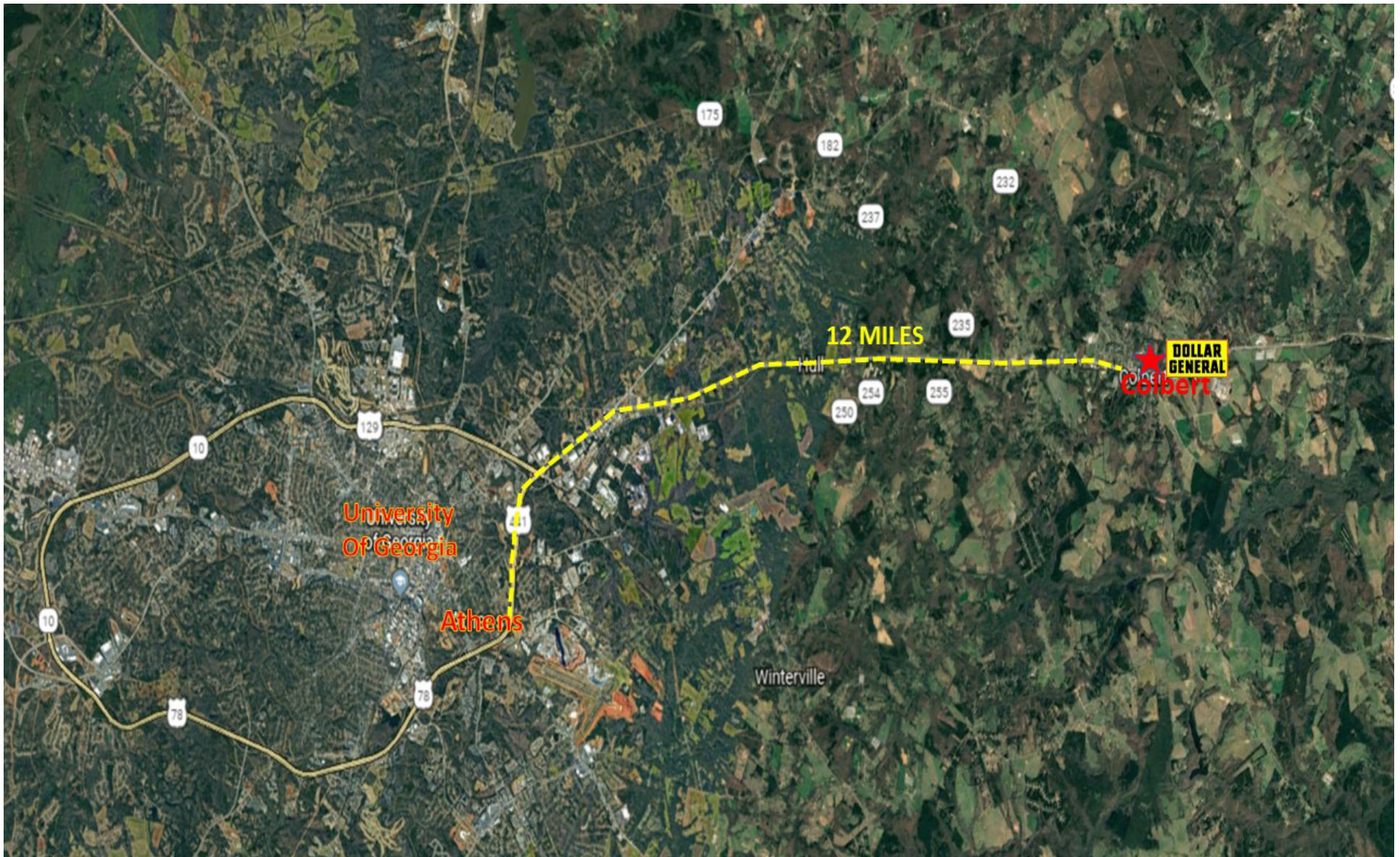
Regional Map

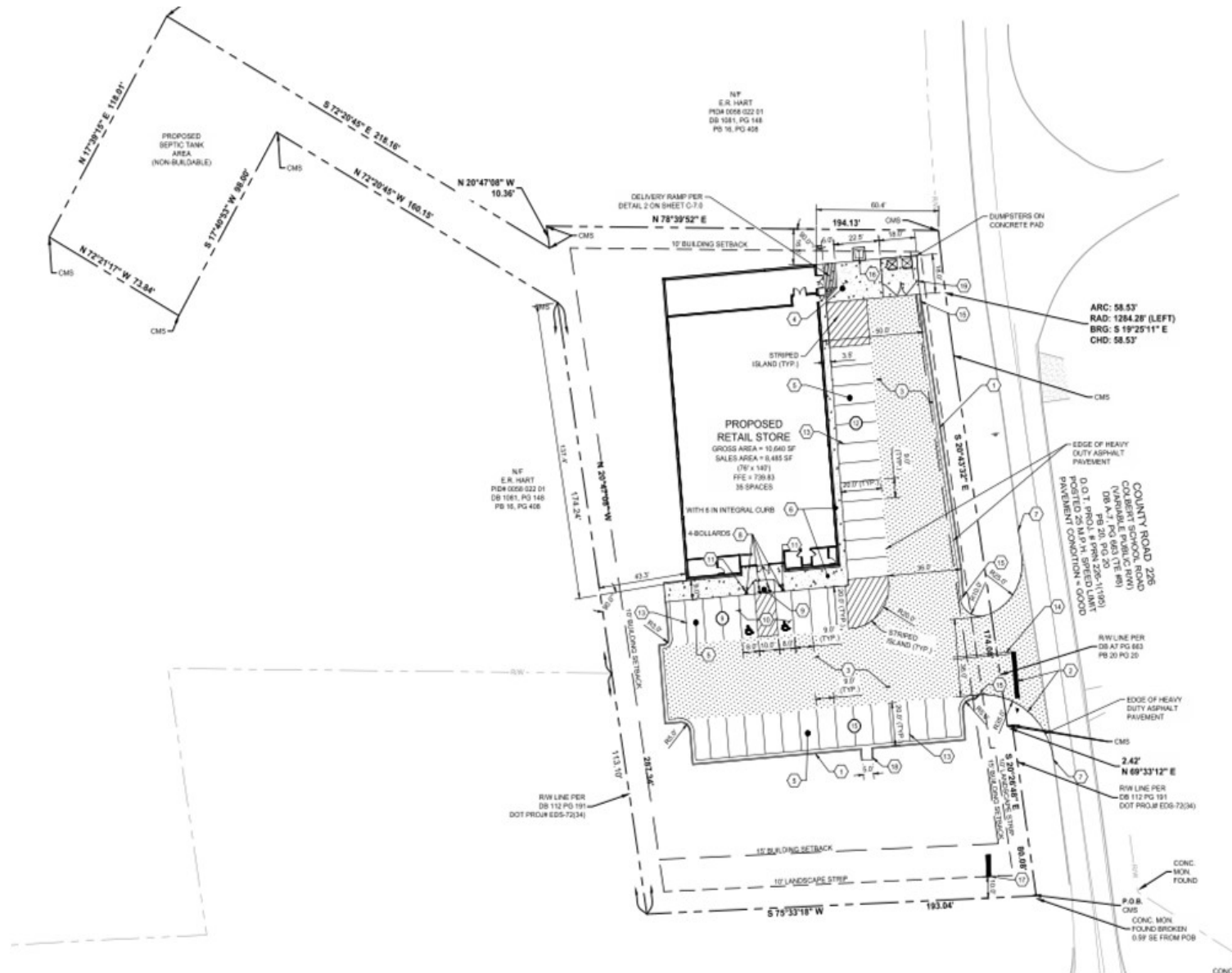
Site Aerial

Colbert, Georgia

The City of Colbert was first chartered as Five Forks in 1899. The roads from Diamond Hill, Danielsville, Comer, Crawford and Athens came together at a point near where the traffic signal is now located. The name of Five Forks was changed to Colbert in 1909 in honor of the Colbert Family, one of the early residents. The city of Colbert is located in Madison County and only 12 miles from Athens, GA. The Madison County Courthouse in Danielsville, Georgia is a historic courthouse built in 1901. It was listed on the National Register of Historic Places in 1980.
