

INVESTMENT OPPORTUNITY



Fresenius Kidney Care Clearwater shares space in a 13,950 SF medical building with Advanced Dermatology and Cosmetic Surgery. Fresenius Kidney Care consists of 10,200 square feet (73.2% of the building) and the Advanced Dermatology space consists of 3,750 SF (26.9% of the building). The Fresenius Kidney Care lease includes scheduled rent increases of 2.25% on an annual basis with three, 5-year options for lease renewal and the Advanced Dermatology lease increases by \$1.00 PSF on an annual basis with two, 2-year options.

The property is easily accessible; located to the west of Route 19, hosting 81,419 cars per day. Other medical office tenants surround the subject property and Mease Dundein Hospital is located just 3.5 miles to the west. Mease Dundein holds 120 patient beds and is currently undergoing a \$19M renovation to expand by 4,000 SF, while 33,000 SF of existing space is undergoing renovation. Westfield Countryside, the largest shopping mall in Clearwater, is directly across from the subject property. Westfield features an array of well-known retailers, such as Dillard's, Macy's, Whole Foods, and PF Chang's.

- Nationally recognized medical tenants, Fresenius Kidney Care and Advanced Dermatology and Cosmetic Surgery are neighboring tenants in one building
- Scheduled **rent increases of 2.25% every year** plus **three fixed-rate, 5-year options** provide for attractive rent growth during the Fresenius lease term






LOCATION AERIAL

LOCATION | CLEARWATER, FL

Clearwater is a city located in Pinellas County, Florida, northwest of Tampa and St. Petersburg. To the west of Clearwater lies the Gulf of Mexico and to the southeast lies Tampa Bay. Clearwater is the county seat of Pinellas County and is the smallest of the three principal cities in the Tampa–St. Petersburg–Clearwater metropolitan area, most commonly referred to as the Tampa Bay Area. Clearwater is known for sunny weather and gulf coast beaches. Clearwater is a great family beach destination, where it's calm, Old-Fashioned Florida and the weather's outstanding. Cleveland Street is one of the city's historic avenues, and the city includes Spectrum Field, where the Phillies pro baseball team plays spring training games. The city is separated by the Intra-coastal Waterway from Clearwater Beach. Clearwater Beach, on a barrier island, is a 3-mile stretch of white sand backed by hotels and restaurants. Injured dolphins and sea turtles are rehabilitated at the Clearwater Marine Aquarium.

ECONOMY

There are an estimated 118,185 residents living in Clearwater Florida. Over the past 20 years Clearwater's population has increased by 8.2%, and is expected to increase by another 3.4% to 122,192 residents over the next five years. The total number of households stands at 51,723; this is expected to increase by 32% to 53,377 in 2025. The area maintains a median household income of \$50,087 which is expected to increase at an annual rate of 1.29% to \$53,404 by 2025; the average household income of \$73,394 is expected to increase to \$81,464 by 2025. The median age of Clearwater's population is 46.3. Demand for Clearwater's 15.1 million SF of retail space is high as evident by a 96.5% occupancy rate.
