





**Hamburg** is a suburb of Buffalo located in Erie county with a current population of 58,105 and one of the best places to live in New York. The economy of Hamburg, New York employs 5,900 people, with the largest industries being health care, social assistance, retail trade and educational services. Buffalo is the 2nd largest city in New York and the largest in western New York. Buffalo is on the eastern shore of Lake Erie, at the head of the Niagara River, 16 miles south of Niagara Falls. Its early embrace of electric power led to the nickname "The City of Light".

Hamburg is a town in Erie County, New York, United States.*The Town is on the western border of the county and is south of Buffallo.* 

**The Buffalo-Cheektowaga-Niagara Falls Metropolitan Statistical Area** is the second-largest metropolitan area in the state of New York, centering on the urbanized area of Buffalo. The combined statistical area (CSA), which adds Cattaraugus, had a population of 1,215,826 inhabitants. It is part of the Great


Lakes Megalopolis, which contains an estimated 54 million people. The larger Buffalo Niagara Region is an economic zone consisting of eight counties in Western New York.
