




Founded in Winston Salem in 1937 by Vernon Rudolf, Krispy Kreme Doughnuts has grown and become an iconic global brand. On April 5, 2000, Krispy Kreme became a publicly traded company on the NASDAQ under the symbol KREM. Then, in 2016, the Luxembourg-based firm JAB Holding Company, owners of many brands including Panera, Einstein Bros Bagels, Peet's Coffee, Au Bon Pain, Caribou Coffee and many more, acquired Krispy Kreme for \$1.35B and took the company private. Krispy Kreme Doughnuts, with sales over \$518M in 2016, now has over 1,300 locations worldwide. Krispy Kreme doughnuts are also sold in grocery stores, convenience stores and supermarkets.




LOCATION MAP





REGIONAL MAP




Overview

The subject is located in Prince George's County. It is part of the Washington Metropolitan Statistical Area (MSA). The Washington-Arlington-Alexandria, DC-VA-MD-WV MSA includes: District of Columbia; Calvert, Charles, Frederick, Montgomery and Prince George's Counties within Maryland; Arlington, Clarke, Culpeper, Fairfax, Fauquier, Loudoun, Prince William, Rappahannock, Spotsylvania, Stafford and Warren Counties, and the Cities of Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas and Manassas Park, located within Northern Virginia; and Jefferson County, within West Virginia.

Population

The Washington MSA is the 6th largest in the nation with a combined population of 6.06MM. The largest places by population in the MSA are the District of Columbia, Arlington, VA; and Alexandria, VA. An annual increase of 1.4% is expected for the Washington MSA for the next five years. Much of the growth, since 2010, within the region has occurred in the District of Columbia.
