EXECUTIVE SUMMARY

The Boulder Group is pleased to exclusively market for sale a single tenant net leased Fast Pace Urgent Care property located in Hanover, Indiana. The Fast Pace Urgent Care lease commences on October 31, 2020 with rent commencing approximately 120 days after. The lease features a 12 year primary term with 7.25% rental escalations in year 7 and in both of the two 6-year renewal options.

The 2,700 square foot urgent care facility benefits from its location near a signalized hard corner along East Lagrange Road (14,250 VPD) which is a primary thoroughfare. The property is positioned directly northwest of Hanover College – a liberal arts college founded in 1827, which has over 1,100 students enrolled. Retailers within the area include CVS Pharmacy, Dollar General, Express Storage, McDonald's, Pizza Hut, and Subway. There are 33,464 people living within 10 miles of the property with an average household income in excess of \$60,000 annually.

The Fast Pace Urgent Care lease expires on October 30, 2032 and features two 6-year renewal options. The lease is also corporately guaranteed by FP Urgent Care, LLC. Fast Pace Urgent Care provides a wide range of services across 105 locations in rural communities. They are currently operating in Tennessee, Kentucky and Mississippi with plans to continue their expansion.






FAST PACE URGENT CARE | HANOVER, IN Site Plan

On October 7, 2009, the dream of Stan Bevis became a reality when the doors to the first Fast Pace Urgent Care Clinic were opened in Collinwood, Tennessee. The dream of providing accessible and cost-effective healthcare to the uninsured and underserved is still part of the company mission today.

With a firm foundation on urgent care needs and in response to our patients' desires for additional services, Fast Pace Urgent Care aims to push for a new vision of healthcare in rural communities that will consist of an array of different services. In order to better represent this goal, Fast Pace modified its name, in January 2020, to Fast Pace Health.

With the addition of staff and continued requests for clinic locations, rapid growth beyond anything that had initially been imagined became a reality. Fast Pace Health has grown from one clinic in Collinwood, TN to clinics throughout Tennessee, Kentucky and Mississippi, with plans for future expansion.

Though the growth continues, there is still very much the same "small town" feel. Each clinic is staffed by locals, and they also provide support staff – maintenance, landscaping, construction and cleaning crews. Each clinic supports the community through membership in their local Chambers of Commerce and by sponsorships of everything from community events, to local charities, to sports teams, and clinic staff is encouraged to volunteer wherever their interests lie.
