


EXECUTIVE SUMMARY:

Rite Aid just signed a new year lease, demonstrating the tenant's commitment to the location. The lease is absolute triple net and features zero landlord responsibilities. There are four 5-year renewal option periods and rental escalations every five years and in each option period. The property also features a drive-thru pharmacy. Rite Aid has a long operating history at this location since 1998.

The 10,908 square foot Rite Aid benefits from its location at the corner of a signalized intersection. The property is outparcel to Walmart Supercenter and near other retailers including Lowe's, Starbucks, ALDI, Giant Eagle Super Market, AT&T, PNC and McDonald's. The Rite Aid is also well positioned just off of Interstate 70 (42,000 VPD), which is a primary east-west thoroughfare.

The Rite Aid lease expires October 26, 2027 and features four 5-year renewal option periods with \$0.50 PSF rental escalations every five years including in each options. 

MARKET OVERVIEW:

Bella Vernon, Pennsylvania

Belle Vernon is a borough in Fayette County, Pennsylvania, United States. It is situated along the Monongahela River abutting two other counties, Westmoreland to the north and Washington across the river. "Bellevernon", as it was originally spelled, was laid out in 1813 by Noah Speer in northwestern Fayette County. French for "beautiful green", this was the name chosen by both Noah Speer for his little community on the Monongahela River and later by his son Louis, who founded a town with nearly the same name just up the hill (North Belle Vernon, Pennsylvania). Directly across the river lies the



borough of Speers, anchoring the far side of the landmark I-70 bridge as the east bridge abutments lie in adjacent Rostraver Township.

Pittsburgh MSA

The Greater Pittsburgh Region is a populous region in the United States, which is named for its largest city and economic center, Pittsburgh, Pennsylvania. There are several official and unofficial boundary definitions, which may be used to describe this region. In the most restrictive definition, the region encompasses Pittsburgh's urban core county, Allegheny, and six nearby Pennsylvania counties.

Garrett Nelson and Alasdair Rae's recent analysis of American commuter flows, "An Economic Geography of the United States: From Commutes to Megaregions", identified the Pittsburgh megaregion as a region encompassing the entirety or significant portions of 54 counties in Western Pennsylvania, Eastern Ohio, Northern West Virginia, and Western Maryland. By this definition, the informal regional boundaries are similar to historical interpretations where the region is defined as the central portion of the Allegheny Plateau to the west and north of the Allegheny Front and south of Lake Erie and Pennsylvania's Northern Tier. The hills and river valleys along the Upper Ohio River and its many eastern tributaries, including the Allegheny and Monongahela rivers have historically been the major centers of population of the region.
