#### **MOUNTIAN OIL EXPRESS**

Founded in 2000, Mountain Express Oil Company ("MEO" or the "Company") is a Georgiabased company focused on the wholesale distribution of gasoline, diesel, racing fuels and lubricants in the southeast United States. MEO is a "jobber", a petroleum marketer that


purchases quantities of refined fuel from refining companies and then markets that refined fuel to both retailers and directly to the end-users of those products. The Company provides petroleum products to 462 locations across 10 states throughout the country.


The Company is growing rapidly, having made 43 acquisitions over the last year, and is currently in process of acquiring another 57 locations to add to the portfolio. Mountain Express Oil is acquiring un-branded locations and re-branding to Conoco stations. The Company will be investing between \$250k and \$1 million into the locations as part of the branding and marketing strategy.


# LOCATION AERIAL







#### JACKSON, MS

Jackson, officially the City of Jackson, is the capital and most populous city of the U.S. state of Mississippi. It is one of two county seats of Hinds County, along with Raymond, Mississippi. The city of Jackson also includes around 3,000 acres (12.1 km2) comprising Jackson-Medgar Evers International Airport in Rankin County and a small portion of Madison County. The city's population was estimated to be 160,628 in 2019, a decline from 173,514 in 2010. The city sits on the Pearl River and is located in the greater Jackson Prairie region of Mississippi.

Founded in 1821 as the site for a new state capital, the city is named after General Andrew Jackson, who was honored for his role in the Battle of New Orleans during the War of 1812 and would later serve as U.S. president. Following the nearby Battle of Vicksburg in 1863 during the American Civil War, Union forces under the command of General William Tecumseh Sherman began the Siege of Jackson and the city was subsequently burned.

Jackson is the anchor for the Jackson, Mississippi Metropolitan Statistical Area. It is the state's 2nd largest metropolitan area, because four counties in northern Mississippi are part of the Memphis metropolitan area. With a 2019 population estimated at 595,000, metropolitan Jackson is home to about onefifth of Mississippi's population.
