**Spring Hill** is a city in Maury and Williamson counties, Tennessee. Located about 30 miles south of Nashville, Spring Hill is conveniently located off I-65, with Saturn Parkway to the south and I-840 to the north, between Columbia and Franklin. Spring Hill is included in the Nashville metropolitan area. Because of its key geographic location, explosive residential development, population boom and high median income, major retail chains have already identified Spring Hill as a prime location such as Target, Home Depot, Lowes, Kohls, Publix, Kroger, Starbucks and many more.

Spring Hill is the home of a state of the art **General Motors Spring Hill Manufacturing.** The plant currently includes vehicle assembly (Cadillac XT5, Cadillac XT6, and GMC Acadia) as well as powertrain, stamping and molding operations. The plant originally operated as the sole manufacturing facility for Saturn Corporation. The plant is the top employer in the area with over 3,170 employees.

Nashville is the capital & most populous city in Tennessee. Fortune 500 companies with offices within Nashville include BNY Mellon, Bridgestone Americas, Ernst & Young, Dell, Deloitte, Nissan North America, Philips, and UBS. Companies headquartered in the city include Community Health Systems, Dollar General, Gibson Guitar, SmileDirectClub, Hospital Corporation of America, Tractor Supply Company, AllianceBernstein, Asurion, Captain D's, LifeWay Christian Resources, Logan's Roadhouse and Ryman Hospitality Properties.

As the "home of country music", Nashville has become a major music recording and production center. The Big Three record labels, as well as numerous independent labels, have offices in Nashville, mostly in the Music Row area.

Nashville is also home to numerous colleges and universities, including **Tennessee** State University, Vanderbilt University, Belmont University, Fisk University, Trevecca Nazarene University and Lipscomb University.
