



#### LOCATION OVERVIEW

Located approximately 24 miles from the Chicago Loop, Chicago Heights is well-positioned on IL Route 30/Lincoln Highway, the area's only east-west thoroughfare for 10 miles. The area is served by two major expressways, Interstate 57 and IL Route 394, each two miles away. Today Chicago Heights is home to one of Ford Motor Company's metal stamping plants that produces automobile body panels that are shipped to Ford's Chicago Assembly plant bout 15 miles north in the Hegewisch community in the Chicago area.
