The subject property consists of 11,440-Square feet and is situated on approximately 1.17 Acres. The location features four points of ingress and egress with a large pylon sign and a double lane drive through pharmacy. There was a new roof installed in 2021 with a 20 year warranty. This location was converted from a Rite Aid in 2019.

Walgreens is subject to a 10-year Double-Net (NN) lease extension, which commenced in 2017. According to Placer.ai, this location is ranked among the top 74% of 63 in the state of West Virginia and ranked #1 within a local 15 mile radius based on trailing twelve months of visitor data. There are 6 years remaining with three, 5-year renewal options and rental increases in each option. Landlord is only responsible for roof and structure.




Wellsburg, WV

Wellsburg is a city in and the county seat of Brooke County, West Virginia. It is part of the Weirton-Steubenville, WV-OH Metropolitan Statistical Area. The 2010 census recorded a population of 2,805. The diverse economy includes several telemarketing facilities, and a factory that does metal fabrication plus plastics molding.

The town was laid out in 1790, and its post office was opened on September 1, 1870. Wellsburg has a number of entries on the National Register of Historic Places. The most notable are Miller's Tavern and Wellsburg Wharf. The Wellsburg Historic District was listed in 1982.

According to the United States Census Bureau, the city has a total area of 1.34 square miles of which, 0.98 square miles is land and 0.36 square miles is water.

The county high school is Brooke High School, part of Brooke County Schools. Wellsburg has one primary school and one middle school, with the county's consolidated high school, nearby. Brooke County Public Library is located in Wellsburg.
