

Every day.® by offering products that are frequently used and replenished, such as food, snacks, health and beauty aids, cleaning supplies, basic apparel, housewares and seasonal items at everyday low prices in convenient neighborhood locations. Dollar General operated 17,426 stores in 46 states as of April 30, 2021. In addition to high-quality private brands, Dollar General sells products from America's most-trusted manufacturers such as Clorox, Energizer, Procter & Gamble, Hanes, Coca-Cola, Mars, Unilever, Nestle, Kimberly-Clark, Kellogg's, General Mills, and PepsiCo.

Earlier in 2021, the Company announced plans to hire more than 20,000 employees during its spring nationwide hiring event. This next effort builds on the success of that program, aiming to support DG's currently-anticipated 1,050 new store openings in FY 2021 with positions available in store, distribution, transportation and corporate operations.

Operating profit for the first quarter of 2021 increased 4.9% to \$908.9 million compared to \$866.8 million in the first quarter of 2020. The first quarter of 2020 included approximately \$80 million of incremental investments the Company made in response to the COVID-19 pandemic, primarily driven by \$60 million in frontline employee appreciation bonuses, as well as measures taken to further protect the health and safety of employees and customers.


LOCATION AERIAL






