

\$1.5 million in Newport Development Fund grants awarded

Available for projects, businesses, and organizations within the city of Newport, the NDF provided for two multi-stage application grant programs - the Newport Development Grant Program and the Discover Newport Business Grant Program.

The Newport Development Grant Program, a competitive grant with a minimum request of \$50,000, was designed to assist impactful projects that align with existing city and regional plans. Increased consideration was given to properties and entities that demonstrated they were adversely impacted by the fraud surrounding local projects perpetrated by Ariel Quiros, Sr.

The city of Newport and the Northern Vermont Development Authority announced the award of about \$1.5 million in Newport Development Fund (NDF) grants. This funding will support the recovery and growth in Newport and the surrounding areas.

"By working with community leaders, and targeting these grant funds for economic development, we can help Newport move further towards economic recovery and growth in the long term."

Awarded Newport Development Grant Program projects include:

Tanguay Homes received \$300,000 to upgrade property infrastructure including clearing the property, building roads, storm sewer system installation, and power trenching. After the completion of the upgraded infrastructure, they will build 19 single-family houses on the property.

The Northeast Kingdom Tasting Center received \$79,500 to make upgrades to their existing facility including a new roof, new decking, new exterior signage, new dock lift, and repairing and upgrading interior ceilings, walls, décor, and floor. The building has been over 70% occupied since opening, creating a vital center of activity in the downtown, with combined employment of over 20 jobs.



Aerospace company in Newport News set to expand and bring new jobs to the area

SEPTEMBER 14, 2021 (13NEWS NOW)

Governor Ralph Northam announced Tuesday that Aery Aviation LLC. -- a commercial services and government contractor for the aerospace industry -- will expand its global headquarters in Newport News.

Aery Aviation will be constructing a 60,000-square-foot hangar facility and engineering technology center with direct access to the Newport News/Williamsburg International Airport. According to Peninsula Airport Commission Chairman Jay Joseph, this agreement is the largest private investment in the history of the airport.

The project will cost \$15.3 million in total and create 211 new jobs. Virginia competed with four additional states for the agreement.

"Hampton Roads' rich history in aerospace and aviation provides an ideal backdrop for Aery Aviation to grow and become more successful than ever before," said Governor Northam. "The region is home to world-class higher education and research institutions that have helped to advance the aerospace industry. We look forward to supporting Aery Aviation as it enters into its next phase of growth here in the Commonwealth."

The Virginia Economic Development Partnership, the City of Newport News, the Hampton Roads Alliance and the Newport News/Williamsburg International Airport worked together to solidify the project.


Governor Northam also approved a \$280,000 grant from the Commonwealth's Opportunity Fund to assist with the security of the project for Newport News.
