
DUNKIN' | Perryville, MD



Perryville is a town in Cecil County, Maryland, United States. The town is located near an access for Interstate 95, on the north side of the outlet of the Susquehanna River. Perryville is the northern terminus of the MARC Penn Line commuter rail service, which runs south to Washington, D.C. via Baltimore. The 1905-built station also serves as a railroad museum and an Amtrak maintenance facility.

Cecil County is at the northeastern corner of the state, bordering both Pennsylvania and Delaware and is part of the Philadelphia-Camden-Wilmington, PA-NJ-DE-MD Metropolitan Statistical area.

The Town offers a variety of services to its citizenry. The Perryville Community Park is open and available for public use. Perryville is the second largest municipality in Cecil County and continues to expand and grow, anchoring the southwest corner of Cecil County. Perryville is also the home of the Perry Point Veterans Hospital, the Perryville Travel Plaza, and the Hollywood Casino-Perryville.



Perryville Economy

The economy of Perryville, MD employs 2.1k people. The largest industries in Perryville, MD are Public Administration (311 people), Retail Trade (250 people), and Health Care & Social Assistance (240 people), and the highest paying industries are Finance & Insurance (\$79,570), Public Administration (\$78,207), and Manufacturing (\$76,908).

The town is home to one of IKEA's distribution centers, which houses one of the largest rooftop solar arrays in the U.S., and the largest in the state of Maryland. The distribution center's total 4.9-MW solar installation of 25,913 panels generates 6,092,533 kWh of clean electricity yearly.

In 2010 Perryville opened the first legal casino in Maryland (Hollywood Casino Perryville). The casino is near the southbound exit of I-95. It offers slot machines, video gaming, table games, and a poker room area. The revenues from the casino are divided with the Town of Perryville and Cecil County government as well as the state.




