The property features an absolute triple net lease which presents zero landlord responsibilities. The lease has approximately 15 years remaining and ten 5-year renewal options with 5% rental escalations in each. Additionally, the property features a drive-thru pharmacy. CVS Pharmacy is an investment grade rated company with a Standard and Poor's rating of BBB.

The 9,855 square foot building is located at a signalized hard corner along 9th Street and North Market Street which hosts a combined traffic count of 16,100 vehicles per day. The property features limited competition in the area. The next closest CVS property is over 12 miles southeast in Indiana. Retailers around Mount Carmel include Verizon, McDonald's, Family Dollar, Burger King, Pizza Hut, NAPA Auto Parts, AutoZone, and Phillips 66. Other traffic draws through the corridor include Wabash General Hospital, Pacific Press Technologies, Kieffer Lumber Co, and Mount Carmel High School. There are 9,089 people living within seven miles of the property who earn an average annual household income of \$67,947.








## CVS PHARMACY | MT. CARMEL, IL Site Plan

# CITY OF MT. CARMEL, ILLINOIS

Mount Carmel is a city in and the county seat of Wabash County, Illinois, United States. At the time of the 2020 census, the population was 7,015, and it is the largest city in the county. The next largest town in Wabash County is Allendale, population 475.

Located at the confluence of the Wabash, Patoka, and White rivers, Mount Carmel borders both Gibson and Knox counties of Indiana. A small community known informally as East Mount Carmel sits near the mouth of the Patoka River on the opposite (Gibson County) side of the Wabash River from Mount Carmel. Mount Carmel is 5 miles (8.0 km) northeast of the Forest of the Wabash, a National Natural Landmark within Beall Woods State Park and about a mile north-northeast of one of its main employers, the Gibson Generating Station. Mount Carmel is also the home of Wabash Valley College, part of the Community College System of Eastern Illinois. Some know Mt. Carmel as Mountain Carmel.

The Evansville metropolitan area is the 164th largest metropolitan statistical area (MSA) in the United States. The primary city is Evansville, Indiana, the third largest city in Indiana and the largest city in Southern Indiana as well as the hub for Southwestern Indiana. Other Indiana cities include Boonville, Mount Vernon, Oakland City, and Princeton. Large towns in Indiana include Chandler, Fort Branch, and Newburgh. Cities in Kentucky include Henderson, Dixon, Providence, and Robards and currently covers an area of 2,367 sq mi (6,130 km2). It is the primary metropolitan area in the Illinois–Indiana–Kentucky Tri-State Area.
