### **PROPERTY OVERVIEW:**

The building was constructed in an upgraded "New England" style and features brick and hardiplank siding as well as asphalt roof shingles. The property is located less than a mile from Naugatuck Valley Community College (NVCC) which has approximately 5,500 undergraduate students on its 110 acre campus. NVCC is also home to Western Connecticut State University's Waterbury campus. Within 1-mile of the property the average house hold income is nearly \$100,000 with over 158,000 people within a 5-mile radius. The daytime employment base within a 5-mile radius is over 67,000 people with over a third of people working in the Education and Health services industries. The property is a short distance from the on/off ramp (exit 17) to the heavily traveled I-84.

#### **LOCATION OVERVIEW:**

Waterbury is a city in the state of Connecticut on the Naugatuck River, 33 miles southwest of Hartford and 77 miles northeast of New York City. It is the fifth most populous city in the state of Connecticut, the ninth in New England, and the tenth in the greater New York City Metropolitan Area. Located in New Haven County, the city had an estimated population of 110,366 at the 2010 United States Census.

The stores are typically located in local neighborhoods and small communities. Dollar General offers both name-brand and generic merchandise—including off-brand goods and closeouts of name-brand items. In 2007 Kohlberg Kravis Roberts & Co. (KKR) (NASDQ: KKR) acquired Dollar General, privatized the company for restructuring, and took the company public again in 2009. As of March 1, 2019, Dollar General Corporation operated 15,472 stores in 44 states.



### Dollar General – Waterbury, CT Site Plan








### Dollar General – Waterbury, CT Location Map
