BRAND NEW FAMILY DOLLAR TREE CONSTRUCTION

The Subject Property was constructed in 2023 and boasts the new Family Dollar / Dollar Tree dually branded prototype. According to Dollar Tree, this new dual branded prototype is driving on average 20% higher sales than the prior Family Dollar units without Dollar Tree features. With the success of the combination format, in 2022 Dollar Tree added 500 new or relocated combo stores and a total of 700 renovations into the combo store format.



HIGHLY PASSIVE LEASE | MINIMAL LANDLORD OBLIGATIONS

The Subject Property is operating under a highly passive corporate guaranteed lease with minimal landlord obligations. The subject lease offers six (6), fve (5) year options to extend with rental increases of \$0.50/SF in the option periods.



INVESTMENT GRADE CREDIT | FORTUNE 150 COMPANY | RAPIDLY EXPANDING RETAILER

In 2015, Dollar Tree acquired Family Dollar, now the Fortune #137 company boasts over 16,340 locations and opened 590 new locations in 2022. Dollar Tree boasts an investment grade credit rating of BBB with Standard & Poor's and as of 1/31/2023 Dollar Tree had revenue of \$28.33B, EBITDA of \$3.00B, and stockholders equity of \$8.75B.



JONESBORO MSA | SECOND LARGEST UNIVERSITY IN THE STATE

The Subject Property is located in Lake City, Arkansas which is a part of the Jonesboro MSA. The Jonesboro MSA has over 135,000 people and is home to Arkansas State University which is the second largest university in the state of Arkansas. Jonesboro is the logistical and economic center of Northeast Arkansas.



TENANT OVERVIEW



Family Dollar was founded in 1959 in Charlotte, North Carolina by Leon Levine. Eleven years later, the company went public and began being traded on the NYSE and shortly after, they opened their 100th store.

Dollar Tree was founded in 1986 in Norfolk, Virginia by Doug Perry, Macon Brock and Ray Compton. Nine years later, the company went public and began being traded on Nasdaq. In the 2000's, Dollar Tree experienced tremendous growth through acquiring competition and growing their store count.

Fast forward to 2015, Dollar Tree acquired Family Dollar and now the retailer is a wholly owned subsidiary of Dollar Tree. Today, the company is the largest and most successful single-price-point retailer in North America, operating 16,340 stores (8,016 Family Dollars locations) across 48 U.S. states and five Canadian provinces.

Family Dollar's corporate strategy is to target suburban and rural communities underserved by other retailers. These low-cost locations, commonly referred to as "food deserts," are intended to provide convenience and discount shopping to area residents that have no nearby access to grocery stores, pharmacies or big-box discount retailers. Family Dollar thrives in middle-America markets where incomes may be modest, proving the tenant to be a resilient and recessions-resistant retailer.



LAKE CITY, ARKANSAS (JONESBORO MSA)

Lake City, Arkansas is a city in Craighead County sitting along the St. Francis River in Northeast Arkansas. The population of Lake City was over 2,300 as of the 2020 census which was almost a 12% increase since the 2010 census and is one of two county seats in Craighead County. Lake City is a part of the Jonesboro Metropolitan Statistical Area and is just 15 miles from downtown Jonesboro.

Lake city is just outside the fifth-largest city in Arkansas, Jonesboro. Located on Crowley's Ridge in the northeastern corner of Arkansas, Jonesboro is one of two county seats of Craighead County. In 2023, the city had a population of 81,969. In 2023, the Jonesboro metropolitan area had a population of 135,287 and a population of 179,932 in the Jonesboro-Paragould Combined Statistical Area. Jonesboro is the logistical and cultural economic center of Northeast Arkansas.

Jonesboro is home to the second largest University in the state of Arkansas, Arkansas State University. With over 14,000 students, Arkansas State sits right behind the University of Arkansas in student enrollment. Arkansas State was founded in 1909 and is considered a public research university. Arkansas State participates as a member of the NCAA Division 1 Sun Belt Conference.
