


BARNESVILLE, OH

Barnesville is a village in Belmont County, Ohio. It is located in the central portion of Warren Township in the western side of Belmont County and is part of the Wheeling, West Virginia Metropolitan Statistical Area. According to the United States Census Bureau, the village has a total area of 1.95 square miles. Barnesville was incorporated as a village in 1835. Barnesville is located only an hour and a half from Columbus and two hours from Pittsburgh, close enough for us to enjoy all that these urban areas have to offer, yet far enough to maintain a hometown atmosphere. The Village of Barnesville had a population of 3,834 as of July 1, 2022.
