ABOUT INDIAN HARBOUR BEACH

Indian Harbour Beach, Florida is on the barrier island in Brevard County across the Banana River from the southern tip of Merritt Island known locally as Dragon Point. It has the Atlantic Ocean beach on its east side and the Banana and Indian Rivers on the west side. Settlers began to come into the area in the years just before and after the U.S. Civil War. The pioneer Floridian William Henry Gleason (1829-1902) owned the land on the barrier island that is now Indian Harbour Beach. Gleason was a prominent politician who became Florida's second Lieutenant Governor and also served briefly as Governor. Indian Harbour Beach was developed in response to the severe housing shortage caused by the massive employment of the space program in Brevard County. Unlike many Florida cities of its 1950s vintage, the town was professionally planned with circular and curvilinear streets and thoughtful placement of commercial and recreational areas.

With its turquoise waters and soft white sand beaches on the Atlantic coast, Indian Harbour Florida is the perfect place to relax and enjoy the sunny Florida weather. 


TRANSPORTATION
