



## Travel Distances From McDonough, GA





McDonough is a city in Henry County, Georgia, 28 miles southeast of downtown Atlanta. Its population was 22,084 at the 2010 census, up from 8,493 in 2000. The town was named for naval officer Commodore Thomas Macdonough and founded in 1823 around a traditional town square design. The town was a relay station on the New York City to New Orleans stagecoach line and was connected by other stage lines with Fayetteville and Decatur, and with Macon by way of Jackson.


